VENDOR INFORMATION

Vendor Hours 7:00 AM – Setup 7:00 PM – Break Down

As a vendor at a Global Women's Summit you will enjoy these benefits:

- ❖ You/your company will receive a 6' table on which to market/sell your products/services. You will have up to two chairs.
- ❖ Your table will have a tablecloth and draped by the venue organization.
- ❖ Tables will be assigned by our team. You will have one hour to set up your table before attendee registration/networking begins at 8:00 AM
- ❖ You will have access to electricity for no additional fee; however, you will be required to reserve it prior to the day of the event.
- ❖ You will be able to bring any display items you wish to this event; however, all of your items must fit on your 6' table. There will be no additional space available to hang banners or stands.

VENDOR DETAILS & CONDITIONS

- ❖ All vendors must fill out a Vendor Application prior to the event.
- ❖ You may set up on Saturday, October 10, 2015 from 7:00 AM until 8:00 AM. **You must be completely set up by 8:00 AM** as this is when attendees begin to arrive.
- ❖ **You may not break down before 7:00 PM.**
- ❖ **To secure your table (they are limited) you must pay your full \$197 fee by September 20, 2015.** After this date, vendor fees will increase to \$297, and there is no guarantee of available space.

- ❖ A maximum of two (2) people will be permitted to work at a Vendor table.
- ❖ Vendors may NOT sell or give away any type of food or beverage without prior written permission from Global Women's Summit.
- ❖ No outside food or drink is permitted to be brought into the event by attendees OR by Vendors for any reason.
- ❖ **All Vendors must check in before they can set up.** Vendors will receive a maximum of two badges which will allow them to come and go at any point before, during, and after the event. These badges must be work throughout the day.
- ❖ **Internet service is not provided by the venue**, so please be prepared to use your own service/network if you need internet access.
